1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification from BlackRock, Inc. (having its registered office at 55 East 52nd Street, New York, NY, 10055, U.S.A.), dated 24 September 2019.

BlackRock, Inc., has notified that, following an acquisition on of UCB shares with voting rights, its holding of UCB shares with voting rights has increased and has crossed the 5% threshold on 23 September 2019.

On 23 September 2019, BlackRock, Inc. (taking into account the holding of its affiliates) Inc. owned 9 887 511 UCB shares with voting rights (versus 9 702 525 shares in its previous notification), representing 5.08% of the total number of shares issued by the company (194 505 658) (versus 4.99% in its previous notification), as well as 467 613 equivalent financial instruments (versus 460 159 in its previous notification) representing 0.24% of the total number of shares issued by the company (same % as in its previous notification).
