1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it has received a transparency notification from BlackRock, Inc. (having its registered office at 55 East 52nd Street, New York, NY, 10055, U.S.A.), dated 25 January 2019.

BlackRock, Inc., has notified that, following an acquisition of UCB shares with voting rights and a disposal of equivalent financial instruments by its affiliates, its total holding in UCB SA/NV has increased and has crossed the 5% threshold on 24 January 2019.

On 24 January 2019, BlackRock, Inc. (taking into account the holding of its affiliates) owned 8 917 622 UCB shares with voting rights (versus 8 848 686 shares in its previous notification), representing 4.58% of the total number of shares issued by the company (194 505 658) (versus 4.55% in its previous notification), as well as 823 002 equivalent financial instruments (versus 835 901 in its previous notification) representing 0.42% of the total number of shares issued by the company (versus 0.43% in its previous notification).
